A quarter of a century ago the editors of two volumes of psychotherapy research reports summarized the state of the field then: Although there has been a great accumulation of clinical observations and experimental findings, the field has made relatively little progress. Research people often find it hard to keep informed of related work done on the same site and elsewhere, and therefore do not build upon each other's foundation (Luborsky and Strupp 1962).
